REGULAR BOARD MEETING

The Regular meeting of the Chairman and Board of Trustees of the Village of Shelton, Nebraska, was convened in open and public session in the Community Room of the Shelton Municipal Building at 219 "C" Street in Shelton, Nebraska at 7:00 o'clock P.M. on DECEMBER 12, 2024.

Notice of this meeting was given in advance thereof by publication in the Shelton Clipper on December 5, 2024, and by posting at 10:30 am on December 5, 2024 in five (5) public places in the Village of Shelton, Nebraska, as follows: Larry's Market, Shelton Clipper, Post Office, Cornerstone Bank, and Village Office, all as shown by the Certificate of Posting attached to these minutes. Notice of this meeting was simultaneously given to the Chairman and all members of the Village Board of Trustees and a copy of their acknowledgement of receipt of notice of the meeting and the agenda are attached to these minutes. Availability of the agenda was communicated in the advanced notice and in the notice of this meeting to the Village Board of Trustees.

All proceedings shown were taken while the convened meeting was open to the attendance of the public.

- 1. CALL MEETING TO ORDER AND ROLL CALL Chairman Roe then called the meeting to order at which time he informed the public of the posting of the Open Meeting Act on the bulletin board in the back of the room and led the audience in the Pledge of Allegiance. He then directed the Village Clerk to call roll which reflected the following: Present: Trustee Roe, Oberg, Rabbe and Anderson. Absent: Keslar
- 2. CONSENT AGENDA. It was then moved by Trustee Oberg to approve the consent agenda which included: A) Waive reading and approve minutes of the regular meeting of November 14, 2024; B) Accept Financial Report and; C) approve C. Shellpeper and J. Kennedy as new members of the SVFR. This received a second from Trustee Rabbe with the vote as follows: AYES: Roe, Oberg, Rabbe and Anderson. NAYS: None. ABSENT: Keslar. Motion Carried.

- 14. UPDATE ON LIBRARY ADA PROJTCT (ARPA FUNDS). The board was presented with the Plans and Specifications for the new ADA parking area. - **16. PURCHASE OF PICNIC TABLE FOR SPLASH PAD AND OTHER LION CLUB PROJECTS.**After discussion, Chairman Roe indicated it was time to consider Resolution No. 24-12-12.

RESOLUTON NO. 24-12-12:

WHEREAS, The Shelton Lions Club will be donating funds in the amount of \$1,697.00 for the purchase of picnic table to be placed near the splash pad in the park and: WHEREAS, after investigation of the facts and discussion of the alternatives, the Governing Body has decided to purchase this table: NOW, THEREFORE, BE IT RESOLVED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF SHELTON, NEBRASKA:

SECTION 1. That the Village of Shelton, Nebraska shall immediately acquire, for the purchase price not to exceed \$1,697.00, one 4' Champ Expanded Metal Free Standing Square Table to be placed in the area of the splash pad, from Commercial Recreation Specialists of Verona, WI. SECTION 2. That the Chairman, and Clerk be and hereby are authorized and directed to acquire the aforementioned equipment and services for and on behalf of, and in the name of the Village of Shelton, Nebraska, and to execute such documents, orders, and contracts in the name of the Village of Shelton, Nebraska, as may be necessary, proper, or convenient to undertake and complete such purchase.

It was then moved by Trustee Oberg, with a second from Trustee Rabbe to approve and adopt Resolution No. 24-12-12 as presented. AYES: Roe, Oberg, and Rabbe. NAYS: None. ABSENT: Keslar. Motion Carried.

17. AGREEMENT WITH MILLER & ASSOCIATES TO APPLY FOR CIVIC AND COMMUNITY CENTER FINANCING FUND (CCCFF) GRANT FUNDS FOR NEW POOL AND BATHHOUSE. After discussion, Chairman Roe indicated it was time to consider Resolution No. 24-12-12A.
