REGULAR BOARD MEETING VILLAGE BOARD OF TRUSTEES JUNE 18, 2024 2:00 PM

The rescheduled regular meeting of the Chairman and Board of Trustees of the Village of Shelton, Nebraska, was convened in open and public session in the Community Room of the Shelton Municipal Building at 219 "C" Street in Shelton, Nebraska at 2:00 o'clock P.M. on June 18, 2024.

Notice of this meeting was given in advance thereof by posting at 9:15 am on June 12, 2024 in five (5) public places in the Village of Shelton, Nebraska, as follows: Larry's Market, Shelton Clipper, Post Office, Cornerstone Bank, and Village Office, all as shown by the Certificate of Posting attached to these minutes. Notice of this meeting was simultaneously given to the Chairman and all members of the Village Board of Trustees and a copy of their acknowledgement of receipt of notice of the meeting and the agenda are attached to these minutes. Availability of the agenda was communicated in the advanced notice and in the notice of this meeting to the Village Board of Trustees.

All proceedings shown were taken while the convened meeting was open to the attendance of the public.

1. CALL MEETING TO ORDER AND ROLL CALL Chairman Roe called the meeting to order at which time he informed the public of the posting of the Open Meeting Act on the bulletin board in the back of the room and led the audience in the Pledge of Allegiance. He then directed the Village Clerk to call roll which reflected the following: Present: Trustee Roe, Keslar and Anderson. Absent: Rabbe and Oberg.

- 2. CONSENT AGENDA. It was then moved by Trustee Keslar to approve the consent agenda which included: A) Waive reading and approve minutes of the regular meeting of May 9, 2024; B) Accept Financial Report; and C) Having the 22/23 Audit report sent electronically to Board members. - 4. AGREEMENTS WITH MILLER & ASSOCIATES FOR; A) SERVICES RELATING TO THE NEW MUNICIPAL SWIMMING POOL & BATHHOUSE AND; B) GAME & PARKS GRANT APPLICATION FOR NEW POOL. Larry Steele from Miller & Associates presented the agreements and answered any questions relating to the new pool project. After discussion, Chairman Roe indicated it was time to consider Resolution Nos. 24-06-11 and 24-06-11A.

- 2. That the Chairman of the Governing Body and Village Clerk be, and they hereby are, authorized and directed to execute such Amendment, on behalf of, and in the name of the Village of Shelton, Nebraska and that an executed copy of said agreement be affixed to this resolution and, by reference, made a part of these official proceedings.
